This kitten has been registered with The International Cat Association (TICA).

### TERMS OF SALE

1. This kitten is guaranteed to be healthy when it leaves our home. **Buyer has 72 hours to bring the kitten to a licensed veterinarian**, at his/her own expense, for a complete examination. If the kitten is found to have any health issues that originated while in the Seller's possession, we will take the kitten back and provide a full refund after being furnished with a letter from the vet indicating why the kitten's health is in question. Buyer must notify us of a problem within 72 hours of picking up the kitten in order to claim this warranty. Injuries/illnesses sustained after leaving the Seller's premises will not be covered by the Seller.

The kitten looks & acts like there is nothing wrong with him/her. \_\_\_\_\_ (Buyers initials)

**Keep in mind that new kittens may show signs of stress including sneezing, runny nose, watery eyes, diarrhea, or constipation when brought into a new environment.**

2. **The kitten has a 1-year guarantee against lethal genetic or congenital defects, including HCM .** Upon being provided an autopsy report from a licensed veterinary pathologist stating the unquestionable genetic or congenital defect, the kitten will be replaced by the first available kitten of equal quality.

3. This kitten will have received two sets of shots (at 8 and 12 weeks) and will be dewormed by the time the Buyer takes the kitten home. The kitten is vaccinated against Panleukopenia, Rhinotracheitis, Calcivirus, and Chlamydia. Shot records will be provided. **This kitten is not allowed to receive FIP or FELV vaccinations**, as they are controversial and pose too many risks. In addition, these vaccines are unnecessary for indoor cats. **Our health guarantee will be void if the kitten is found to have received these vaccines.** Kittens should only be vaccinated with "killed-virus" or "modified-live-virus" vaccines, not "live virus".

4. Kittens that are sold as pet-only or for show & will be altered by the owner/buyer, must be altered by the time they are nine months old. Seller will be provided with proof of altering (a copy of the veterinarian's written certification w/name, date & type of cat included). Then kitten's registration application/papers will be forwarded within 30 days. If ten (10) months have passed and Buyer has not sent Seller the proper proof of altering, then the Buyer will pay the Seller \$800 for a Traditional or \$1000 for a Mink, which represents the cost of breeding rights. The original registration papers will be held on this kitten until such proof is provided or compensation has been made. Reasonable attorney fees incurred in upholding this contract will be paid by Buyer. Kittens that are altered by the Seller will receive the registration papers at the time the kitten goes home.

5. **Under NO circumstances is this kitten to be declawed!** The kitten should already be accustomed to using a scratching post by the time it leaves our home.

6. **This kitten is never to be allowed outdoors.** Due to their non-aggressive behavior and inability to protect themselves sufficiently, Ragdolls are meant to be indoor cats.

7. **Under NO circumstances will this kitten be sold, leased, traded or given to any pet shop, kitten mill research lab, or anything else.** If the buyer can no longer care for the kitten or wishes to give the kitten up for any reason (other than for the health issues discussed above), the kitten **MUST** be returned to us without refund.

8. This kitten has known nothing but unconditional love. Buyer is responsible for providing this kitten with kindness, compassion, love, and proper attention, which includes quality cat food, fresh water daily, playful interaction (both with people and with toys), a clean/sanitary litter box, and regular veterinary care.
